About Obra Thermal Project

It is situated in district Sonebhadra about 12 KM from Chopan railway station, about 8 KM off Varanasi-Shaktinagar road. It is about 125 KM from VARANASI, which is connected by air/rail and road route from all major cities in India. India's first 50, 100 and 200 MW thermal plant is installed at Obra. New 2X660 MW units is also proposed here.

Eligibility Criteria

1. A recognized National/International level reputed Institution /Organization having motto to serve the society.
2. Experience in successful running of Co-Educational Schools from Nursery to XII standard under the CBSE Syllabus for not less than 20 years at a stretch.
3. The Institution will be well established with a Central body, operating more than 100 schools in more than four states in India as per CBSE guidelines up to standard XII.
